As per the recommendations of Statutes on affiliation of colleges of Nursing adopted by the Executive Council of Dr.NTR UHS in October, 1996 and as amended in July, 2003, it is hereby certified that the application of **Viswashanthi College of Nursing, R.T.Nagar, PENCHIKALAPADU (V), Kurnool** sponsored by Viswabharathi Educational Society, Gayathri Estate, Kurnool for starting of B.Sc.(Nursing) 4 years Course has been registered with Dr.NTR University of Health Sciences, Vijayawada and as per the orders of the Vice-Chancellor, vide reference 10th cited, Provisional Affiliation is granted for starting of 1st year B.Sc.(Nursing) 4 YD Course and for admitting students with an intake of 50 (Fifty) for the academic year 2019-20, subject to final orders of the Supreme Court of India regarding submission of renewal of recognition/permission from Indian Nursing Council, New Delhi for the academic year 2019-20.
