## **ORDER:**

As per the recommendations of Statutes on affiliation of colleges of Nursing adopted by the Executive Council of Dr.NTR UHS in October, 1996 and as amended in July, 2003, it is hereby certified that the application of Viswashanthi College of Nursing, R.T.Nagar, Penchikalapadu (V), Kurnool sponsored by Viswasharathi Educational Society, Gayathri Estate, Kurnool for B.Sc.(Nursing) 4 years Course has been registered with Dr.NTR University of Health Sciences, Vijayawada and as per the orders of the Vice-Chancellor vide reference 9th cited, Conditional Affiliation is granted for starting of 2nd year B.Sc.(Nursing) 4 YD Course and for admitting students with an intake of 50 (Fifty) for the academic year 2020-21 subject to final orders of the Supreme Court of India regarding submission of renewal of recognition / permission from Indian Nursing Council, New Delhi for the academic year 2020-21 and also subject to the following condition:

## **Conditions:**

- 1. Shall obtain permission of the APNMC, Vijayawada every year.
- 2. The Physical facilities, clinical facilities, teaching and other staff should be as per the Norms of Indian Nursing Council, New Delhi and as per Dr.NTR UHS Statutes.
- 3. The Dr.NTR UHS may conduct surprise inspections at any time for verification of college facilities.
- 4. In case if any of the information furnished by the Institution is false or misleading the University has a right to withdraw the permission without further notice.

The Number of students admitted shall not exceed the number of students permitted for annual admissions both under University and Management quota as specified by the Indian Nursing council / Dr.NTR UHS.

The fee collected by what so ever name called either for University quota seats or for Management seats should not exceed the limits specified by the State Government / Dr.NTR UHS from time to time.

The college authorities shall follow the regulations made by the State Government / Dr.NTR University of Health Sciences / Indian Nursing Council in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any violations in this regard may lead to disaffiliation of the college without any notice.
